The president gave a short report of the work done on the community property since last year. This included the repair of the eroded cliff, maintenance of the road surfaces, and emergency repair to the plugged drains at the bottom of Crystal Beach Road during the winter.

DRAINS: Don Winterton reported his success at having the County replace the drain at the stop sign and clear all the ditches up to the APA road. It was agreed that a letter of thanks be sent to Watcom County for their work to date, to be followed by a letter requesting that the roads in Waldron and Saturna be repaired.

Marian Tulley reported a drainage problem on the bluff in front of their house and Jim Barker also reported similar problems in front of Carters. A suggestion was made to use covered drains. No volunteer was forthcoming to head up a drains committee so the president will arrange a work-party at a later date during the summer. It was duly moved,

seconded and approved that up to \$400 be set aside for drains. To dispell the gloom, Dan Scott reported the drain at

his house worked very well during the heavy flooding.

<u>ROADS</u>: Gerry McClintock suggested perhaps Watcom County would do some extra road work on a contract basis. Don Winterton agreed to pursue the possibility of resurfacing the private lower roads when he contacts them about Waldron and Saturna. Up to \$2000 was approved for this project.

TREES: There was a general discussion about the possibility of the trees in front of Dr Rantas' house being dangerous and whether or not they are on community property. The president agreed to contact the tree expert named by Don Winterton to inspect the trees in question. If the trees are hazardous, the president will contact the Rantas to inform them of this and that if they are on community property it is our responsibility to make them safe. Dan Scott agreed to get a work-party together to remove the trees on the cliff in the general area near his house.

<u>BEACH PATH</u>: This is of concern to many people. We need new handrails and general repairs. Of more importance was the poor access at the bottom near the beach. Gerry Mc Clintock and Rod Hurston volunteered the services of the men in the upper section of the plat to build steps at the bottom of the stairs this year. The upper part will be left until drains and roads are attended to. Peggy Viner proposed that up to **\$100** be spent on the lower stairs. This was agreed to unanimously.

DUMPING: Once again NO DUMPING OVER THE BLUFF OR ON ANY VACANT LOT WITHIN THE PLAT. Each person to look after disposal of their own garden waste and garbage! Fred Culbert agreed to take care of disposal of grass clippings for the community bluff property. The Association will pay up to **\$50** for expenses that are incurred for this service.

RAFT: Don Aven offered to build a light-weight raft for about **\$100.** Approval was moved by Peggy Viner, seconded by Doris Culbert and passed.

<u>CONSTITUTION</u>: Please search attics etc. for copies of the old constitution. It was suggested that Henry Sivertz may have a copy. So please Henry when you receive these minutes could you look too and send it with your suggestions for improvement to us.

DUES: \$35 this year please per household.
